***Total inmate COVID-19 tests completed: 37,349***

***57% of current inmates have received at least one COVID-19 vaccine dose. To-date 1,582 inmates eligible to receive a booster shot have been boosted and an additional 310 inmates have received a second booster dose.***

***Note: These totals do not include 2,416 inmates who were released after receiving COVID-19 vaccination while in DOC custody. Offender deaths: 13 (12 from complications from serious chronic diseases and COVID-19 and 1 from complications from COVID-19; 8 from James T. Vaughn Correctional Center and 5 from Sussex Correctional Institution).***
