## ADDENDUM 1

**CONTRACT NO.:** DOC22027-PHARM  
**CONTRACT NAME:** Correctional Pharmaceutical Services  
**VENDOR NAME:** Correct Rx Pharmacy Services, Inc.

WHEREAS, the Delaware Department of Correction (“DDOC”) and Correct Rx Pharmacy Services, Inc. (“Provider”) are parties to Contract # DOC22027-PHARM (“Agreement”) executed with an effective date of July 1, 2022; and

WHEREAS, pursuant to Appendix 1, Sections 6.1 and 6.3, the cost/pricing may be adjusted annually based upon the current Philadelphia All Urban Consumers Price Index (“CPI-U”), U.S. City Average. The CPI-U used shall reflect the percentage change during the previous published twelve (12) month period. Should the percentage change be greater than 3%, the annual adjustment shall be capped at 3%; and

WHEREAS, the published twelve (12) month period of the CPI-U in June 2023 is 3.1% and therefore the annual cost/pricing adjustment shall be capped at 3% effective July 1, 2023; and

FOR AND IN CONSIDERATION, DDOC and Provider agree to amend the existing Agreement as described below.

Appendix 1:

6.1 Staffing costs for five (5) on-site pharmacists shall be invoiced on a monthly basis at the rate of ~~\$15,400.00~~ \$15,862.00 per FTE.

6.3 Notwithstanding the Provider’s proposed clinical incentives defined in its Best-and-Final-Offer, each monthly invoice shall include either a dispensing fee of ~~\$2.81~~ \$2.89 per medication prescription or a management fee of ~~\$9.52~~ \$9.81 per offender per month, whichever is lowest for the monthly period.

All other services rendered shall be in accordance with the same terms and conditions as set forth in the original Agreement effective July 1, 2022.
