Audit Findings

Audit Narrative

The on-site PREA audit of the Delaware Department of Correction Plummer Community Correction Center, Wilmington, DE, was conducted on June 18, 19,20,2018 by certified PREA auditor Clayton S Kellum. The facility supplied the auditor with a list of staff, training records, positions, and shifts. Also, copies of contracts staff and volunteers. The auditor was given copies of all policies documents as it related to PREA standards, procedures, and program curriculums. The facility supplied auditor with resident's rosters with resident name, date of birth, custody level, unit, cell and bed. To ensure that there was consistency in the sampling the auditor included at least one staff member of each shift and locations. The on-site audit began with the meeting on Monday, June 18, 2018, at 8:30 AM in a staff conference room. The following staff attended the meeting: Warden, Deputy Warden, facility PREA Compliance Manager, and Agency- wide PREA Coordinator, Captain, Staff Lieutenant, Mental Health, Medical Department, Director of Nursing, Treatment Administrator, Counselor Supervisor, Director Crest North, and Supervisor Crest North. The auditor began the tour of Plummer Community Correction Center at approximately 9:00 AM and completed at approximately 6:30 PM. During the tour the auditor reviewed PERA notifications, blind spots, camera placements, mirrors, staff assignment, logbooks, policy and procedures and documentation to determine compliance. While touring the facility, staff and residents were interviewed in private and in common areas to determine that residents were receiving the same information as it related to the PREA program. During the close- out of the audit the following staff attending the meeting: Warden, Deputy Warden, facility PREA Compliance Manager, the Agency-wide PREA Coordinator, Captain, and Staff Lieutenant, Director Mental Health, Director of Nursing, Treatment Administrator and Counselor Supervisor. During the close- out the auditor went over the process that would follow the on-site audit to including corrective measures, any addition photos, documentations, work orders, etc. Also, the auditor explained that any areas found not to meet the standards during the on-site must be corrected and documented and the auditor would work with the facility to accomplish PREA compliance. It was evident from communication with the Agency-wide PREA Coordinator prior to the audit, during the audit and after the audit that she takes PREA and sexual safety very seriously. The auditor acknowledged the hard work and professionalism of the staff and their willingness to accomplish PREA compliance. Finally, the auditor advised the facility their requirement to post the final report on the agency website once compliance with all the standards were achieved

Facility Characteristics

Delaware Department of Correction-Plummer Community Correction Center is located at 38 Todds Lane, Wilmington, DE 19802. Plummer Community Correction Center is a time built prison with minimum security designation for housing adult males for the state of Delaware. At the time of the audit there were 156 residents housed at Plummer Community Correction Center. There are three buildings located inside a 12-foot fence. The secured perimeter includes such buildings as food-service, administration, education, religious, resident housing, unit management, and recreation, visitation, and staff offices. All housing units, recreation area, classrooms and any area that was accessible to the residents were toured. The facility was clean and very well maintained and there was no issue concerning food, religious service, and visitation. Plummer Community Correction Center is a work-release center located in Wilmington, Delaware. This re-entry facility works with Delaware Department of Correction integrating soon to be released residents into society and the workplace. The minimum security detail is for the residents to get transported to a day job on the outside and come back to facility in the evening. Plummer Community Correction Center is a halfway house for male residents and has a capacity of 256 residents. Residents will be provided with a supported living environment with the ultimate goal of successful re-entry. This will be accomplished through a phased- base model emphasizing accountability. This facility is a level IV of five levels which is the last stage for residents before release. The housing units reflected the population of the state. The demographics of the facility will allow a diverse population to better understand lifestyle and tradition of people with different backgrounds. The number staff employed by the facility at the time audit was 74.

Generally, PREA notifications existed throughout the institution, especially within each housing area. In addition, there was a notice on each door of each unit of the requirement for opposite gender announcements. Pictures were taken that indicates the placing of PREA notices. Some areas that did not have a PREA notice were remedied with the placement of the PREA notice before the tour ended. This included the education area. As stated, these areas had PREA notices before the end of the tour of the facility. During the tour of a Housing (Herron) area the auditor noticed that the bathroom on Housing was missing a stall wall. Work orders were submitted to install urinal partition in the bathroom on Housing Unit. Subsequent pictures indicated that the wall have been installed. Additionally, glass frost was install in the holding cell door window to prevent accidental viewing of residents in the holding cell. Again, this work was done before the end of the tour. There were at total of 41 standards, one (1) exceeded and 40 met standard. This indicated to the auditor the hard work and dedication it took to attain and exceeds the standards. The Delaware Department of Correction Plummer Community Correction Center staff and management takes the PREA program very serious. They showed respect

to residents and the resident population was well aware of PREA and felt that if they (residents) had to file a PREA complaint the facility would respond and follow upon it in a timely manner. All corrective actions were taken on and completed in a timely manner. Therefore, the Delaware Department of Corrections Plummer Community Correction Center are in compliance with the PREA standards

Delaware Department of Correction- Plummer Community Correction Center has written policy that outlines the agency's approach to preventing, detecting and responding to incidents of sexual harassment and sexual abuse. The procedure for staff was outline in the DDOC policy 8.60-115.11. The agency does employ an agency-wide PREA Coordinator and the position is in the upper level of the agency hierarchy. During the interviews with the PREA Coordinator and the PREEA manager, both indicated they had significant time and authority to develop, implement and oversee the facility's efforts to comply with the PREA standards issued be noted that the standard is on the website. The PREA manager is also assigned an additional facility to coordinate the PREA standards. The PREA manager has been able to manage both facilities and maintain compliance. Also, the agency-wide PREA coordinator who has only been on the job for a few months also demonstrated outstanding performance. The facility exceeds the standards.

These findings are based on staff and administrative interviews, along with documentation provided by the facility, and it was determined the Delaware Department of Correction- Plummer Community Correction Center does include the provision of obligation to adopt and comply with the PREA standards in all new contracts and contract renewal. Also, the Plummer Community Correction Center provides a contract monitor for all new and renewed agency contracts to ensure that contractors are complying with the PREA standards as required. The facility demonstrated compliance with the standard.

Based on interviews with line, intermediate-level, higher-level supervisors, DDOC 8.6-115.213 and the review of documentation provided, the Delaware Department of Correction Plummer Community Correction Center there is a finding of "full compliance". In regard to these finding for this standard, it was found that the facility has documented and complied on a regular basis with the staffing plan. Further, the facility has procedures in place to ensure any deviation to the staffing plan are covered by overtime, and/or roster adjustments in order to remain compliant with the staffing plan. Notifications of deviations must be documented and submitted to the warden explaining the reason(s) for the deviation(s). Also, the staffing level are monitored daily by review of the shift rosters. Along with administrative staff interviews, which mandated an annual review of the staffing plan each calendar year and approved by the Warden, Deputy Warden and the agency PREA Coordinator. The facility demonstrated compliance with the standard.

These findings are based on Delaware Department of Correction, Plummer Community Correction Center DDOC policy 8.6 0A, 8.60, 8.60-115.215, staff interviews, training record reviews, training curriculums and other documentation provided. The following was determined by the auditor. A review of the training curriculums and staff interviews indicated that cross gender strip searches are prohibited except in exigent circumstances and must be approved and documented when they occur. During the past 12 months, there have been no documented cross-gender strip searches or visual body cavity searches reported. Since the other no female residents housed at this facility, staff interviews, and documentation revealed the absence of male employees engaging in frisk/pat searches of female residents and no cross-gender searches in the past 12 months. Delaware Department of Correction, Plummer Community Correction Center, DDOC PREA policy, states that residence shall be permitted to shower, perform bodily functions and change clothing without non-medical staff of the opposite gender viewing their buttocks or genitalia. During the interviews by the auditor the residents confirmed that the residents had privacy when showering, using the toilets and changing clothes. Further, during interviews with staff and residents and through observation it will revealed that opposite gender announcements were commonplace. The announcements were made even when the unit officer was female (s). DDOC PREA policy 8.60-11.215, training curriculum and staff interviews prohibits staff from physically examining transgender and /or intersex residents for the sole purpose of determining genital status. DDOC PREA policy 8.60, training curriculum, staff interviews and staff training records reviews showed that the facility trained security staff to conduct cross-gender pat-down searches and searches of transgender, and intersex residents in a professional and respectful manner. The facility has demonstrated compliance with the standard.

The facility always refrains from placing residents at high risk for sexual victimization in involuntary segregated housing unless an assessment of all available alternatives has been made, and a determination has been made that there are no available alternative means of separation from likely abusers. Interviews of staff and residents revealed no incidents of involuntary segregated housing being used for this purpose in the last 12 months. Residents who are placed in segregated housing because they are at high risk of sexual victimization have access to programs, education, privileges, and work opportunities to the extent possible. If the facility restricts access to programs, privileges, education, or work opportunities, they document the opportunities that have been limited, the duration of the limitation, and the reasons for such limitations on the DACS forms which would only occur until the resident is transferred to a more secure facility. Again, there were no incidents during the last 12 months. The facility affords a review to determine whether there is a continuing need for separation from the general population every 30 days.
